
- t. Tamara Who is going to contact Josh to make sure that they have an Accessibilities email and that someone is aware of that?

 - Rachel I think this is a really interesting idea however I don't know how feasible it actually would be. We do have that past and

So I think the feedback that we've are maybe concerns about the format and similar to this, time limits, topics, and if we were really trying to borrow from these delegates to get together they would run like that. 





- F. Jared Thanks for bringing this to the table. Sometimes the financial aspect was a big deciding factor on whether or not I could serve on council. It has been a huge blessing to attend as a member of council. 10 years is a long time and prices have definitely gone up. I think \$100 for more or less four days of eating is a little crazy so that's my opinion.
- G. MK Yeah I'm in favor of this for sure. This is an Accessibilities issue. I actually haven't thought about flights being bought in advance I think that its super helpful feedback. I don't want potential council members to not step up because we only cover half of stuff sometimes. I think this is a small step in the right direction.
- H. Joe I think it needs to be adjusted. I'd like to see us have a credit card and book these up front rather than reimbursements for account purposes. For accounting purposes these are expenses.
- I. Kelsey I serve on Finance as well and I agree they need to be adjusted for both. Site selection, we have to be there and we have a lot less time to book flights and they can be more pricey. I appreciate everyone's feedback.
- J. James H We should just be reimbursing people for reasonable airfare. I was doing some research and that wasn't even the cost of a domestic ticket in 2010. Obviously we need to trust people to be wise with ICYPAAs money but we should just reimburse people for airfare. Inflation since 2010 is just under 21% so if you index that the \$100 goes to \$120 or \$150 although it probably should be higher. I don't see the need to change the hotel because it's not dollar indexed. We outta just be covering people's flights and helping people buy them in advance.
- K. Katie E I definitely agree this should be looked at. I don't have anything additional on it. Good job.
- L. Chris I totally agree with what James said.
- M.Mo I'm on Finance and appreciate everyone's feedback and for




the record I do think it needs to be adjusted.

- N. Katie R I definitely think it needs to be adjusted and don't have anything new to add.
- O. Tyler I'm pretty much in agreement with what everyone has said. I was looking at flights and based on where we fly out of, its going to change the price. We don't want a council member to stress out about money to fulfill their service commitment.
- P. Rachel I definitely think it needs to be looked at and I agree with everything that has been said.

- S. General round of discussion regarding ICYPAA attendance:
 - a. Tamara I would like to make a suggestion that if someone is unavailable due to Covid that they may be able to attend and vote virtually. So they aren't getting their voice silenced. They're prepared for that weekend anyways via virtual platform. Business meetings, site selection, etc. We would have to figure that out.
 - b. Jared I don't really see the merit if they feel comfortable doing it specifically. I think if we passed some kind of temporary amendment to the policy that allows this year as an exception. It will give people the freedom to attend virtually.
 - c. MK I'm in favor of letting people have flexibility this year and possibly going forward and I personally don't know if I feel comfortable attending just yet. I think giving people flexibility will be great.
 - d. Joe I think that my opinion is, the best course would be vague right now and waive the attendance policy. I trust you Phillip to work with people who can't be there to attend virtually. I just want to keep it vague right now.
 - Kelsey I'm totally in favor of flexibility. I am not totally comfortable attending in person but want to serve in



- whatever capacity I can from home. I don't know whether its better to waive the attendance policy now before logistics but giving people flexibility this year is important.
- f. James H I think we should blanket waive the attendance policy this year. I'm with Joe and I trust you and the OC to figure out how people may attend virtually. I also think its important to think about how to handle people sitting on a zoom call for four straight days. I think that's an accessibility issue as well for some people.
- g. Katie E I agree with what everyone has said. I think we should just waive the policy. It's been a wild ride.
- h. Chris I agree with a lot of what has been said but I think the only thing to keep in mind is that I think it's important for council members to attend the conference. I know this year is a crazy year but I would want to be cautious that we don't set a precedent. It's a year that makes sense or makes adjustments.
- i. Mo I'm in agreement with a lot of what has been said. I think it's important for us to be flexible with ourselves as we have been with others. I would hope that we would all be able to make the annual business meeting, we do them throughout the year. I'm inclined to say yes across the board but I don't know. The annual business meeting is an important time to do business. In general, full support.




- agree its an accessibility thing everyone's circumstances should be considered.


- V. Shannon Thinking about the bylaws and what all that entails. Does this mean they would get a vote for site selection or would that be a separate motion?

- X. Shannon Yes I understand what the motion means but I'm just making sure that there's nothing in the bylaws that ties




those things together.


